

## Did you know?

---

After taking care of your loved ones, you can gift a remainder of your estate to Volunteering Gold Coast. You can either specify the size of your gift or gift a percentage of your estate.

A Codicil is an effective way to make updates without re-writing your entire Will. If you decide to leave a gift to Volunteering Gold Coast and already have a Will, a codicil is the easiest, and least expensive way to update your existing Will.

### Suggested wording for your Will:

I give to the Volunteering Gold Coast Limited (ABN 47 631 886 431) for its general purposes, free of all duties \_\_% of my residuary estate of which an authorised receipt from the Volunteering Gold Coast will be a sufficient discharge for the executor(s) or trustee.
